Arcona Property Fund N.V. update on share buyback

Arcona Property Fund N.V. (the Fund) – a listed fund that invests in commercial real estate in Central Europe – has repurchased, in the period from September 29, 2022 to October 5, 2022, 6,367 ordinary shares of the Fund at an average price of EUR 6.51 per share. The total acquired amount in cash terms is EUR 41,433.

These shares have been acquired as part of the share buyback programme announced on September 14, 2022, for an amount of up to EUR 1.5 million. Under this programme, a total of 37,322 shares of the Fund have been acquired to date for a total amount of EUR 251,701.

The acquired shares will be cancelled in due course upon a resolution of the Shareholders' Meeting to reduce the Fund's capital. This share buyback funding allocation is part of a larger tranche of up to EUR 10 million, which the Fund, in consultation with shareholders, is aiming to return to shareholders in due course from the proceeds of the ongoing sales programme of non-core real estate assets.
